AMENDMENT TO DECLARATION OF CONDOMINIUM OF THE REEF, A CONDOMINIUM

The following amendments are made to Articles IV, VII, IX, XI, XXI and XXVI of the DECLARATION OF CONDOMINIUM OF THE REEF, A CONDOMINIUM, recorded in Official Records Book 2094, Page 1627, *et. Seq.*, of the Public Records of Brevard County, Florida (additions are indicated by underlining, deletions are indicated by ~~striketrough~~, and omitted but unaltered provisions are indicated by ellipses):

IV

APARTMENT BOUNDARIES, COMMON ELEMENTS, AND LIMITED COMMON ELEMENTS

The owner of any condominium unit shall be responsible for any and all damages caused to the common elements or the limited common elements by the willful act, negligence, or other actions causing any damages to the common element or limited common elements, whether caused by the unit owner, the unit owner's tenants, guests, or invitees. The unit owner is responsible for any such damages, including, but not limited to, damages caused by delaying any repairs, renovations, or maintenance to the common elements or limited common elements, and shall pay any and all such costs to the Association, and any and all costs not paid within thirty (30) days of written demand by the Board of Directors may be charged as a special assessment of the condominium unit responsible for said damages or costs and may otherwise be enforced and foreclosed as provided for in this Declaration.

VII

ADMINISTRATION OF CONDOMINIUM BY THE REEF CONDOMINIUM ASSOCIATION, INC.

The operation and management of the condominium shall be administered by THE REEF CONDOMINIUM ASSOCIATION, INC., a corporation not for profit, organized and existing under the laws of the State of Florida, hereinafter referred to as the "Association".

The Association shall have all of the powers and duties incident to the operation of the condominium as set forth in this Declaration and the Articles of Incorporation and Bylaws of the Association, as well as all the powers and duties set forth in the Condominium Act where the same are not in conflict with or limited by this Declaration and said Articles and Bylaws. True and correct copies of the Articles of Incorporation and the Bylaws are attached hereto, made a part hereof, and marked Exhibit "B" and "C", respectively.

The Association shall further have the power to impose fines upon unit owners, to enforce violations of this Declaration, the Bylaws, the Articles of Incorporation, and to enforce any and all Rules and Regulations established by the Board of Directors and of the Association. All unit owners, their tenants, guests and invitees, and all residents and members of the Association, agree to comply with all of said terms and conditions and with the terms and conditions of the Florida Condominium Act, as may be amended, from time to time.

IX

COMMON EXPENSES, ASSESSMENTS, COLLECTION LIEN AND ENFORCEMENT, LIMITATIONS

~~Special assessments may be made by the Board of Administration from time to time to meet other needs or requirements of the Association in the operation and management of the condominium and to provide for emergencies, repairs, or replacements, and infrequently recurring items of maintenance. However, any special assessment which is not connected with an actual operating, managerial, or maintenance expense of the condominium, shall not be levied without the prior approval of the members owning at least thirty of the apartments in the condominium.~~

The Board of Administration of the Association shall have the authority, by a vote of a majority of the Board of Directors, to impose special assessments to meet the operational, management, maintenance, repair and renovation obligations of the Association. The Board of Directors shall also have the authority, by vote of a majority of the Board of Directors, to specially assess all Units for any other matters within the authority of the Board of Directors, including, without limitation, the hiring of professionals and outside vendors. The Board of Administration of the Association shall also have the authority to impose a special assessment against individual Units, as set forth in Article XI, Paragraph b. of the Declaration.

XI

RESPONSIBILITIES FOR MAINTENANCE AND REPAIRS

b. The Association, at its expense, shall be responsible for the maintenance, repair, and replacement of all the common elements and limited common elements, including those portions thereof which contribute to the support of the building, and all conduits, ducts, plumbing, wiring and other facilities located in the common elements, for the furnishing of utility services to the apartments, and including artesian wells, pumps, piping, and fixtures serving individual air-conditioning units. Painting and cleaning of all exterior portions of the building, including all exterior doors and windows, except sliding glass doors, windows and screens opening onto patio porches and walkways shall also be the

Association's responsibility. Should any damage be caused to any apartment by reason of any work which may be done by the Association in the maintenance, repair or replacement of the common elements, the corporation shall bear the expense of repairing such damage. All unit owners, and other residents, tenants, guests and invitees, shall fully cooperate with the Association's employees, agents, contractors or vendors for any and all repairs, maintenance or renovations of the common elements and limited common elements, including providing any and all access required to a unit, when requested to do so with not less than twenty-four (24) hours prior notice of the need to access a unit. If access to the unit or any portion thereof should be denied by a unit owner, a tenant, guest or other resident of the unit, after notice is provided to the unit owner (or placed upon or within the unit), the unit owner shall be liable for any additional fees, costs or charges imposed upon the Association by reason of said failure to cooperate or by reason of the delay in providing access to the Association, its employees, vendors or contractors. Any such additional fees or costs shall be promptly paid by the unit owner, and, if not promptly paid, may become a special assessment as to that unit owner or owners, enforceable as provided for in this Declaration.

d. In the event owners of a unit fail to maintain it as required herein or make any structural addition or alteration without the required written consent, the Association or an owner with an interest in any unit shall have the right to proceed in a court of equity to seek compliance with the provisions hereof. The Association shall have the right to levy at any time a special assessment against the owners of the unit ~~for the necessary sums to put the improvements within the unit in good condition and repair or to remove any unauthorized structural addition or alteration.~~ the costs of correcting unauthorized structural alterations or other changes made without the Association's approval, and the Association shall have the right to specially assess the unit owner for any and all additional costs incurred by the Association, should the unit owner, its tenants, guests, invitees or residents fail to cooperate with the Association in making said repairs or restoration or should the unit owner, its tenants, invitees or other residents interfere with said repairs or renovations or otherwise delay any such remedial work, repairs or renovations. After making such assessment, the Association shall have the right to have its employees and agents enter the unit, at reasonable times, to do such work as deemed necessary by the Board of Administration of the Association to enforce compliance with the provisions hereof.

XXI

RESPONSIBILITY OF APARTMENT OWNERS

The owner of each apartment shall be governed by and shall comply with the provisions of this Declaration as well as the Bylaws and Articles of Incorporation of the Association. Any apartment owner shall be liable for the expense of any maintenance, repair or replacement made necessary by his act, neglect or carelessness, or by that of any members of his family, or his or their

guests, employees, agents or lessees, but only to the extent that such expense is not met by the proceeds of insurance carried by the Association. Such expense shall include, but not be limited to, any and all additional costs, fees or other expenses incurred by the Association due to any lack of cooperation, interference or any actions, whatsoever, including the failure of the owner, the owner's family, guests, lessees or licensees, to provide access to the unit when requested by the Association or its contractors or vendors, and said costs and expenses shall be payable to the Association by the unit owner upon request, and if not timely paid, may become a special assessment as set forth under this Declaration. ~~Such liability shall include any increase in fire insurance rates occasioned by use, misuse, occupancy, or abandonment of an apartment. Nothing herein contained, however, shall be construed so as to modify any waiver of right of subrogation by insurance companies.~~

In any action brought against an apartment owner by the Association for damages, or injunctive relief due to such apartment owner's failure to comply with the provisions of this Declaration or Bylaws of the corporation, the Association shall be entitled to court costs, reasonable attorney's fees, including appeal and expenses incurred by it in connection with the prosecution of such action.

XXVI

REMEDIES FOR VIOLATIONS

For violation or a breach of any provisions of this Declaration by a person claiming by, through or under the Developer, or by virtue of any judicial proceedings, the Association, and the members thereof, or an institutional first mortgagee, or any of them severally, shall have the right to proceed at law for damages or in equity to compel a compliance with the terms hereof or to prevent the violation or breach of any of them, or for such other relief as may be appropriate. In addition to the foregoing right, the corporation shall have the right, whenever there shall have been built within the condominium any structure which is in violation of this Declaration to enter upon the property where such violation of this Declaration exists, and summarily abate or remove the same at the expense of the owner, provided, however, the corporation shall then make the necessary repairs or improvements where such violation occurred so that the property shall be in the same condition as it was before said violation occurred, and any such entry and abatement or removal shall not be deemed a trespass. The failure promptly to enforce any of the provisions of this Declaration shall not bar their subsequent enforcement.

The Association shall have the power to enforce the provisions of this Declaration, the Associations Articles of Incorporation, the Association's Bylaws, any Rules and Regulations adopted pursuant to any of these other documents or any amendments to these documents. In any proceeding arising because of an


alleged failure of an apartment owner or the Association to comply with the terms of any combination of the Association's Governing Documents, the prevailing party shall be entitled to recover, his, her or its reasonable attorneys' fees, paralegal fees and costs of the proceeding against the other party by the Association.

Reasonable attorneys' fees, paralegal fees and costs of the proceeding are recoverable whether or not suit is initiated and also as may be awarded by any state, federal or bankruptcy court, any arbitrator, any administrative law court or administrative agency, and at trial or appellate levels.

Any and all reasonable attorneys' fees, paralegal fees and costs of the proceeding that are charged by the Association pursuant to this provision for costs and attorneys' fees may be charged as a lien against the apartment where which is the subject of such proceeding and such lien may be foreclosed against such apartment in the manner prescribed in this Declaration or as provided by Florida law, as may be amended, from time to time, as the case may be.
